### FROM THE VICE PRESIDENT

#### Journey to a homebuilt aircraft Part 2

In the last newsletter, I told you that I had decided to build the Barracuda. It is an all wood, 2 seat, 250 horsepower retractable gear aircraft.

I was on my way to see Mr. Bill Beuthe to see his Barracuda and buy a set of plans – hoping that today I would get my first ride in a homebuilt aircraft.

Driving north on the I-15 near Temecula California my hopes were dashed as I

was in the middle of a downpour. But as I approached Ernst field thirty minutes later, the rain had let up.

I met Mr. Beuthe and he mentioned that it did not look like a good flying day.

Ernst Field is a dirt strip and was not looking good after the rain. Bill showed me around his hangar where he had his completed Barracuda and another one in progress. He then invited me to lunch at his house which was just up the hill overlooking the runway.

Two hours had gone by , so we went down and walked the runway. It was wet but solid. Bill said we were good to go flying.

Ernst Field is narrow dirt runway next to a creek with tall bushes. As Bill pushed the throttle forward I felt incredible acceleration. Soon we were lifting off and the bushes at the edge of the runway were whizzing by at almost 100mph.

Initial climb was showing 2,000 feet per minute. We settled into a laidback cruise at 3,500 feet at 195 mph! Bill let me have the stick, but this was not a Cherokee.

The controls were quick and responsive but intuitive. Bill continued the demo flight with slow flight and the gentle stall

that the Barracuda was designed for. I was sold.

I was on my way home with a set of Barracuda plans. I very quickly made an order from Aircraft Spruce. Working with wood was interesting.

Steaming and forming spruce is not easy but after a few months I had the structure for a vertical stabilizer and rudder.

Boom! Life happened and I found myself with no place to build an aircraft. The Barracuda has a 24 foot one piece wing. It was now 2001 and the project was stalled.
